The main purpose of the Annual Meeting will be to elect three (3) members to the Board of Directors of the Association for 3-year terms. The community may transact any other business that may properly come before the meeting. The expiring positions are currently held by Jasbir Chowdhary, Greg Hymel and Wayne Swann. Jasbir 'Rani' Chowdhary will be seeking reelection and her nomination statement is enclosed for your review. We have received 3 additional nomination applications from Eduardo Barcelo, Nasrin Brebbia and Rich DiPippo whose nomination statements are also enclosed for your review. Members may also make nominations from the floor and may nominate themselves or other members at the evening of the Annual Meeting. An applicant must be present at the meeting to accept the nomination. The applicant must also be current in his/her assessment fee to serve as a director. If you are willing to serve on the Board of Directors and are willing to accept fiduciary responsibility on behalf of your fellow members, we encourage you to seriously consider serving on the Board.

Please pay close attention to the instructions on how to fill out and mail each form. Forms filled out and/or sealed incorrectly will be invalidated. This packet contains the following contents listed below.

#### QUORUM PROXY

- 1. If you will not attend the Annual Meeting, please fill out the 2024 QUORUM PROXY. This form is different from the DIRECTED PROXY form. Filling it out will guarantee a quorum for the meeting in your absence. Without a quorum, the community will not be able to conduct the meeting. This will significantly hinder the Board's ability to function properly.
- A quorum, which is the presence, in person or by proxy, of Members representing at least one sixth (1/6) of the total authorized votes (48 homes), is required to hold this meeting. Follow the instruction sheet to submit your Quorum Proxy.
- 3. If quorum is not present at the scheduled Annual Meeting date, the procedures set forth in Section 11B-111(6) of the Maryland Homeowners Association Act, for the calling of an additional meeting will be invoked. At such additional meeting, those members present in person or by proxy shall constitute a

quorum. The Additional Meeting will be held on Tuesday, July 16, 2024, at 7:00 PM at the Hampshire Greens Golf Course Clubhouse Pavilion.

#### **DIRECTED PROXY:**

If you will <u>not</u> attend the Annual Meeting, please fill in the Directed Proxy. Filling it out allows you to vote to fill vacated Board seats. Without a quorum of election votes, the community will not be able to fill vacated Board seats. This will significantly hinder the Board's ability to fulfill its fiduciary duties. Follow the instruction sheet to submit your Directed Proxy.

#### **DIRECTIONS FOR VOTING**

Ballots will be provided for voting at the meeting. Inspectors of Election will be appointed at the meeting. They will be responsible for counting the votes by Proxy Ballot or Ballot and returning the results during the meeting to the presiding officer of the Board.

The meeting was called to Order at 7:45pm by President, Wayne Swann.

#### We want you to know about the Montgomery County Commission on **Common Ownership Communities**

Montgomery County recognizes that a substantial proportion of all its citizens now live in condominium, cooperative, and homeowner associations, generally called "common ownership communities." In order to serve better the special needs of these communities, to act as their advocate, and to maintain and improve the quality of life in these communities, the county created the Commission on Common Ownership Communities, operating under the authority of Chapter 10B of the Montgomery County Code.

The commission has 3 basic duties:

Education: The commission provides free information to both members and governing bodies about their rights and duties under Maryland law, as well as advice on how to properly operate the association, and avoid complaints. Among other tools, it offers a "Community Manual and Resource Guide" for boards of directors, and detailed information on such topics as architectural control, assessments, and meetings - all of which can be found on the commission website. It also publishes a newsletter summarizing recent developments affecting common ownership communities. Commissioners will speak to communities and their boards on request and welcome invitations to do so.

Legislation: The commission advocates for common ownership communities concerning proposed laws and regulations at the local and state level.

Dispute resolution: The commission can hear and resolve certain disputes between members of the communities and their governing bodies, and its decisions are legally binding on the parties. Copies and easy-to-read summaries of its decisions are posted on its website and reviewed in its newsletter.

The commission is composed of 15 volunteers who are appointed for three-year terms. Eight members must be residents of common ownership communities and the other seven must be professionals who work with the communities, such as property managers, lawyers, developers, and realtors. Every fall, the county publishes a request for applicants to the commission to replace those whose terms are due to expire.

<u>Section 2.12</u>. "Property" shall mean and refer to all real property as may hereafter be brought within the jurisdiction of the Association pursuant to Article 2 of the Declaration.

Any other capitalized terms used herein shall be defined as set forth in the Declaration unless specifically provided otherwise in these Bylaws.

### ARTICLE 3 Meeting of Members

- <u>Section 3.1.</u> <u>Annual Meetings.</u> The first annual meeting of the Members shall be held within twelve (12) months from the date of filing of the Articles of Incorporation of the Association, or within sixty (60) days of the date of conveyance of fifty percent (50%) of the Lots which may be annexed within the Property, whichever occurs earlier, and each subsequent regular annual meeting of the Members shall be held on the same day of the same month of each year thereafter or such other reasonably similar date as may be selected by the Board of Directors. If the day for the annual meeting of the Members is a legal holiday, the meeting will be held at the same hour on the first day following which is not a legal holiday.
- <u>Section 3.2.</u> <u>Special Meetings</u>. Special meetings of the Members may be called at any time by the President or by the Board of Directors, or upon written request of the Members who are entitled to vote one-sixth (1/6) of all of the votes of the Class A membership.
- Section 3.3. Notice of Meetings. Written notice of each meeting of the Members shall be given by, or at the direction of, the Secretary or person authorized to call the meeting, by mailing a copy of such notice, postage prepaid, or hand delivering a copy of such notice, at least ten (10) days (but not more than ninety (90) days) before such meeting to each Member entitled to vote thereat, addressed to the Member's address last appearing on the books of the Association, or supplied by such Member to the Association for the purpose of notice. Such notice may be waived upon the declaration of an emergency by the person calling the meeting. Such notice shall specify the place, day and hour of the meeting, and, in the case of a special meeting, the purpose of the meeting. All meetings of the Members shall be held at places and times convenient to the greatest number of Members.
- <u>Section 3.4.</u> <u>Quorum.</u> The presence at the meeting of Members entitled to cast, or of proxies entitled to cast, one-sixth (1/6) of the votes of each class of membership shall constitute a quorum for any action except as otherwise provided in the Articles of Incorporation, the Declaration or these Bylaws. If, however, such quorum shall not be present or represented at any meeting, the Members entitled to vote thereat shall have power to adjourn the meeting from time to time, without notice other than announcement at the meeting, until a quorum as aforesaid shall be present or be represented.
- <u>Section 3.5.</u> <u>Voting.</u> At every meeting of the Members, each Class A Member shall have the right to cast one (1) vote for each Class A membership which he owns on each question. Each of the Class B Members shall have the right to cast one (1) vote for each Class B membership which he owns on each question. The vote of the Members representing fifty-one
